# Cretex Companies Privacy Policy

#### 1. Introduction

#### 2. Information We Collect

We may collect information from you when you use the Service and when you contact or interact with us.

## A. Information You Provide to Us

When you submit a contact request through the Service, you may provide some personally information to Cretex including your name, email address, city, state, and any other information that you provide.

When searching for a position with Cretex, you will be redirected to another website, run by ApplicantPro, which hosts our job listings, such as

of Use govern the services that it provides, personal information that you submit while applying for a position on ApplicantPro's website – like your name, address, previous addresses, email address, and telephone number – may be provided to Cretex for employment purposes.

# B. Information We May Collect Automatically When You Use the Service

When you access and use the Service, we may automatically collect information regarding you and your device, including your device's internet protocol address, the domain name of your internet service provider, your location, your mobile device information (e.g., device model and operating system version), your page visits, and aggregated information that cannot be used to specifically identify you. Additional information collected is described in the **Analytics** and **Cookies, Local Storage and Other Tracking Technologies** sections below.

We may use the information that we collect for several purposes, including:

- To provide services to you;

- To identify you as a user of the Service;
- To connect with your social media accounts;
- To send you information about your relationship or transactions with us;
- To enable you to provide comments and participate in questions and answers;

- To contact you with information, including promotional information, that we believe will be of interest to you;
- To provide relevant advertising;
- To display relevant advertising across websites;
- To create anonymous data and to compile aggregate data, which we may use for any purpose, including for internal and external business purposes;

- To generate and review reports and data about our user base and service usage patterns;

# 4. Legal Bases for Processing Your Information (for users in European Union)

## Performance of a contract

The use of your personal information may be necessary to perform the agreement you have with us to provide products and services. For example, to respond to your requests.

The personal information that you submit to ApplicantPro while online may be accessed and downloaded by Cretex professionals located in the United States through a secured connection to the

ApplicantPro database and used for evaluating your qualifications for the job for which you have applied and other jobs that may suit your experience and qualifications. In addition, the provisions of this policy relating to use of information apply to any information that may be accessed or downloaded by Cretex from the ApplicantPro database.

You may receive emails or text messages from ApplicantPro about your application, such as an email or text message thanking you for submitting your resume.

Other than ApplicantPro, Cretex does not share resume or application information with third parties without specific authorization from you.

## C. Business Changes

If we become involved in a merger, acquisition, sale of assets, joint venture, securities offering, bankruptcy, reorganization, liquidation, dissolution, or other transaction or if the ownership of all or substantially all of our business otherwise changes, we may transfer your information to a third party or parties in connection therewith.

#### D. Affiliates

### E. Investigations and Law

We may disclose information about you to third parties if we believe that such disclosure is necessary to:

- Investigate, prevent, or take action regarding suspected illegal activities, suspected fraud, the rights, reputation, safety, and property of us, users or others, or violations of our policies or other agreements with us;
- Comply with the law or guidance and cooperate with government or law enforcement officials or private parties;
- Respond to claims and legal process (for example subpoenas); and/or
- Protect against legal liability.

## F. Aggregated Information

We may share aggregated information relating to users of the Service with affiliated or unaffiliated third parties. This aggregated information does not contain personal information about any user.

## G. Analytics

We use third party analytics tools to better understand who is using the Service and how people are using it. These tools may use cookies and other technologies to collect information about your use of the Service and your preferences and activities. These tools collect information sent by your device or

### 6. Cookies, Local Storage, and Other Tracking Technologies

We, along with third parties, use cookies, local storage objects, web beacons and other technologies. These technologies are used for analyzing, personalizing, and optimizing the Service.

Cookies are small files that are transferred to and stored on your device through your web browser (if you allow it) that enable the website's or service provider's system to recognize your browser and capture and remember certain information. You can instruct your browser to stop accepting cookies. But if you do not accept cookies, you may not be able to use all portions of all functionality of the Service.

### 8. Data Retention, Managing Your Information

We will retain your information for as long as you use the Service and for a reasonable time thereafter. We may maintain anonymized or aggregated data, including usage data, for analytics purposes. We may retain and use your information as necessary to comply with our legal obligations, resolve disputes, enforce our agreements, and/or for the period required by laws in applicable jurisdictions. Please note that some or all of the information we have collected may be required for the Service to function properly.

## 9. Links to Other Websites or Applications

# 11. EU Privacy Rights

  - the information is used for direct marketing purposes, in which case we will immediately stop processing the user's information for such purposes.
- The right to lodge a complaint with the data protection supervisory authority of the EU member state where the user resides.
- The above legal rights are subject to various conditions and exceptions including where the data is used for statistical or scientific research purposes and the exercise of the right would prevent such purposes from being attained or would seriously impair their attainment.

# 12. Information Collected from Other Websites, Cretex's Do Not Track Policy

Through cookies we place on your browser or device, we and our partners may collect information about your online activity after you leave the Service. Just like any other usage information we collect, this information allows us to improve the Service and customize your online experience, and otherwise as described in this privacy policy.
